

1. Purpose. To promulgate rules and regulations governing the use of Naval Amphibious Base Little Creek (NAVPHIBASE LCREEK) Tennis Courts. Changes to this instruction constitute a major revision; therefore, additions, deletions, or changes are not individually marked.

2. Cancellation. NAVPHIBASELCREEKINST 1710.20E is hereby cancelled.

3. Background. The Storefront Morale, Welfare, and Recreation (MWR) Department, NAVPHIBASE LCREEK is responsible for the organization and operation of assigned tennis courts. They shall meet the requirements promulgated by reference (a), and directives of higher authority, including safety procedures. Enclosure (1) sets forth the rules and regulations.

RULES AND REGULATIONS FOR NAVPHIBASE LCREEK TENNIS COURTS

1. Mission. The NAVPHIBASE LCREEK Tennis Courts are operated for the purpose of promoting leisure time activities which will effectively contribute to the mental and physical well-being of Naval personnel and their family members.

2. Location. The following tennis court complex is available at NAVPHIBASE LCREEK:

3. Extension of Privileges. The following personnel are authorized to use the NAVPHIBASE LCREEK Tennis Courts:

a. Active duty, reservist, retired personnel, and their family members.

b. DOD civilians working on the NAVPHIBASE LCREEK, provided space is available.

c. Guests of the above personnel on a limited basis as authorized by the Commanding Officer.

4. Hours of Operation. Normal tennis court hours are from 0800-2200. Since an established schedule for maintenance is impractical, players may be required to vacate a court in order for the court to be serviced.

5. Operating Regulations. The Storefront Morale, Welfare, and Recreation Tennis Pro Shop concessionaire will enforce the following regulations to the maximum extent possible and they will be adhered to by all patrons.

a. All players must be dressed in appropriated attire to include shirt and smooth-soled tennis shoes with socks. Ridgesoled shoes are not permitted.

b. With the exception of tennis courts located adjacent to the Tennis Pro Shop, which will be scheduled by reservation only, courts are to be utilized on a first-come basis. Under no circumstances will play exceed 1 ½ hours if others are waiting. Reservations for one court in the Pro Shop complex can be scheduled by calling 462-8118. Reservations may be made on the day prior to day of play. Time frames begin at 0830 and are in intervals of 1 ½ hours.

c. Dependents under 12 years of age must be accompanied by a playing eligible sponsor.

d. All courts shall be vacated and secured at 2200 daily. Patrons will ensure the area is clean and orderly prior to vacating.

e. Beverages are permitted provided they are in unbreakable containers.

f. Pets shall not be permitted inside the fenced area of the courts.

g. Small children must be under the control of a non-playing individual at all times when within the fenced area of the courts.

h. The Resident Tennis Professional is the only person authorized to teach or give formal instruction on NAVPHIBASE LCREEK Tennis Courts.

i. Tennis lessons, individual, group, and juniors are available from the Resident Tennis Professional. All information and rates are available at the Tennis Pro Shop.

j. Pro Shop services include stringing, lessons, and sale of the latest in tennis apparel. For further information, contact the Resident Tennis Professional, 462-8118.

k. Pro Shop Hours of Operation:

Monday through Saturday	0900-1700
Sunday	0900-1400 (Seasonally)

l. Tennis courts are provided for the enjoyment of eligible users. Attention to common courtesy and the etiquette of tennis by all players will assist in attainment of this objective and will assist NAVPHIBASE LCREEK in maintaining the courts in optimum condition.
