NAVPHIBASELCREEK INSTRUCTION 5728.2

Subj: ENTERTAINMENT MOTION PICTURES

Ref: (a) BUPERSINST 1710.11 (Series)

1. Purpose. To promulgate policy governing the operation of the Base Theater at Naval Amphibious Base Little Creek (NAVPHIBASE LCREEK).

2. Background. In accordance with the provisions of reference (a), the Commanding Officer, NAVPHIBASE LCREEK is permitted to exhibit entertainment motion pictures. Motion pictures are acquired by the Navy Motion Picture Service (NMPS) under a term lease program covering a period of years with the film industries. The NAVPHIBASE LCREEK Storefront Morale, Welfare, and Recreation Office then receives the motion pictures from NMPS.

3. Administration. The exhibition of entertainment motion pictures is a direct function of the Storefront MWR office. The Storefront MWR Director shall ensure strict compliance with the provisions of article 116 of reference (a).

4. Eligibility. In accordance with reference (a), the following personnel are authorized to attend the exhibition of entertainment motion pictures at the NAVPHIBASE LCREEK Base Theater:

- a. Active Duty military personnel and their family members.
- b. Reservists and their family members.
- c. Retiree military personnel and their guests.
- d. Civilian employees of NAVPHIBASE LCREEK.

5. Regulations of Dependent Children. ID cards will be shown by all children 10 years of age and older. Children under 10 years of age must be accompanied by an adult to all performances. Children who are 10 years of age or older must have their military ID cards on their persons to remain in the theater unattended.

6. Admission Fee. A nominal fee is charged for all persons over two years of age attending the theater. There will be no admission charge for children under two years of age. Current admission fees are promulgated periodically by NAVPHIBASELCREEK Notice 1710.
